

The regular meeting of the Truman City Council was held March 6, 2017 at 7:00 p.m. The meeting was called to order by Mayor Brownlee.

1. MINUTES

A motion was made by Hendricksen, seconded by Brownlee to approve the minutes of the last regular meeting held February 21, 2017. All yeas- carried.

2. PRAIRIELAND - CONDITIONAL USE PERMIT RENEWAL

Prairieland Solid Waste Director Billeye Rabbe presented an update on activities at the plant during the last year. They have nine full-time employees and one new part-time office assistant.

Councilor Mosloski arrived.

The plant is now 25+ years old and is operating in the black. The south building was rebuilt and currently they are doing office renovations. They will be reconstructing the concrete drive area this year.

A motion was made by Ebert, seconded by Nickerson to approve the annual renewal of the Conditional Use Permit for Prairieland Solid Waste. All yeas - carried.

3. JORDAN LAMPMAN - HIRED AS FIREFIGHTER

Fire Chief Dave Bentz was present to recommend hiring Jordan Lampman as a new firefighter. The background check has been completed. He lives in Fairmont but works during the day in Truman. The fire department will be voting next week on changing the bylaws to allow for this.

A motion was made by Hendricksen, seconded by Nickerson to approve hiring Jordan Lampman as a firefighter contingent on the amendment of the firefighter bylaws to allow for this. All yeas - carried.

4. RESOLUTION APPROVING STATE OF MINNESOTA JOINT POWERS AGREEMENTS WITH THE CITY OF TRUMAN ON BEHALF OF ITS CITY ATTORNEY AND POLICE DEPARTMENT - RESOLUTION 2017-3

Police Chief Justin Jobe presented a resolution to renew the joint powers agreement with the Department of Public Safety and the BCA for the e-citation program. This will be good for five years.

A motion made Hendricksen, seconded by Mosloski to approve Resolution 2017-3. All yeas - carried.

5. SOLAR ENERGY SYSTEMS ZONING ORDINANCE - PUBLIC HEARING SET

The planning and zoning commission had met and recommended that city council adopt the proposed solar energy systems zoning ordinance.

A motion was made by Hendricksen, seconded by Nickerson to hold a public hearing on Monday, April 3, 2017 at 7:00 p.m. to receive public comment on the proposed solar energy systems zoning ordinance. All yeas - carried.
