

The regular meeting of the Truman City Council was held June 19, 2017 at 5:30 p.m. The meeting was called to order by Mayor Brownlee.

1. MINUTES

A motion was made by Ebert, seconded by Mosloski to approve the minutes of the last regular meeting held June 5, 2017. All yeas - carried.

2. SWIMMING POOL REPORT

Swimming Pool Commissioner Faith Clow reported that the pool is celebrating its 50th anniversary this year on July 20 from 5 - 7 p.m. Clow asked for permission to purchase can cozies to sell and to throw at the parade. It would cost \$540 for 1,000 of them. Also discussed the two quotes she has to replace the toilets and sinks in the original bathhouse. Clow also asked for permission to purchase plastic tables and chairs for the pool. Two baby changing tables will be purchased for the new bathrooms. A report will be drawn up with the costs of the pool remodeling project as well as a list of donations. Woodchips will be added to the pool playground and the new shower heads will be cleaned. Men's and women's signs will be purchased to put up by shower rooms.

3. CAROL WHITE

Carol White was present with concerns about the neighbor by her rental house empty lots moving an old yellow pickup and leaving ruts in the alley. She said the city should fix it. She also had issues with her renter being told to remove a fire pit. Police Chief Justin Jobe said the renter was told to put out a large fire but was not told he had to remove the fire pit. White had to remove several alcohol containers from the rental property lawn. Mayor Brownlee asked White if she felt she had all her concerns answered and she said yes.
