1. MINUTES

A motion was made by Nickerson, seconded by Mosloski to approve the minutes of the last regular meeting held March 19, 2018. All yeas - carried.

2. QUARTERLY DEPARTMENT REPORTS

Fire Chief Dave Bentz presented the quarterly fire department report. They are at full staff and have had eight runs so far this year. The fire trucks have been repaired after the large Northrop elevator fire and roughly \$5,000 of costs turned into insurance for reimbursement. The floor coating on east bay of the fire hall is pealing. Bentz is working with the vendor to get the issue resolved.

Street Superintendent John Bosshart reported on the street department. The wing on the payloader snow plow has been repaired. They hope to start sweeping streets as soon as it warms up. Bosshart has been talking to the John Deere rep about the rented utility tractor that is up for renewal in June. It would cost an additional \$5 per hour to add a mower deck to the tractor. Talked about getting the holes patched on the concrete street south of Casey's General Store.

Police Chief Justin Jobe presented the police report. He is waiting for delivery of the new squad car. He has the parts ready for the install.

3. PART-TIME POLICE OFFICER JARED GRAY HIRED

Police Chief Justin Jobe recommended hiring Jared Gray as a part-time officer. He is a part-time officer for Martin County and his physical and psychological tests are still valid.

A motion was made by Mosloski, seconded by Hendricksen to hire Jared Gray as a part-time police officer. All yeas - carried.
