5. SWIMMING POOL UPDATE

Swimming Pool Commission members Faith Clow, Kim Breamer and Kirsten Bressler were present to give an update on the upcoming season. They would like to give an incentive for the guards to take the necessary training. The lifeguard training is \$200 and the water safety instructor (WSI) training is a little bit more. One idea was to give them \$100 per year for two years if they work at least 20 hours per week or 3 days a week. They have to take a refresher every two years. The pool commission will come up with a suggestion on training reimbursement. Last year's manager would come back for \$13/hour but the commission felt that they wanted to keep the current pay scale the same for the manager. They have two guards interested in the manager position. There are four new lifeguards this year. There will be an early sign up again this year. The pool deck is in need of replacement. Councilor Ebert said it would be around \$4/square foot for concrete to do that. Will look at fundraising for this project. There will be some mini golf course improvements this year as well. The pool will open June 2.

6. MISCELLANEOUS

Request for a pay increase for the park and recreation youth workers was denied.

Gave approval for a street light to be added in the 500 block of E. $1^{\rm st}$ Street South.

Will invite the city engineer to the next meeting to discuss drainage issues on North $3^{\rm rd}$ Avenue East.

Interviews will be held by the city council on May 14 & 15 for the city administrator position.
