### 1. MINUTES

### 2. SPEED LIMIT CHANGES AROUND SCHOOLS AND GRAF PARK

Police Chief Justin Jobe read the state statutes on authority to change speed limits on residential streets. It allows 25 mph on residential streets and 20 mph around school zones. The council's main concern was around the schools and the park for safety of children in those areas.

A motion was made by Mosloski, seconded by Hendricksen to change the speed limits on the following streets in the appropriate 20 mph and 25 mph zones:

First Street South from Central Avenue to Highway 15

Fourth Street North from Central Avenue to Second Avenue East Central Avenue from Third Street North to Fifth Street North First Avenue East from Third Street North to Fourth Street North Second Avenue East

Third Avenue East from First Street South to Third Street North Fourth Avenue East from Ciro Street to Second Street South Second Street South from Fourth Avenue East to Highway 15 First Street North from First Avenue East to Fourth Avenue East

All yeas - carried.

#### 3. TRUMAN DAYS DONATION

A motion was made by Mosloski, seconded by Ebert to accept a \$1,757.28 donation from the Truman Baseball/Softball Association from the Truman Days Raffle and to make a \$1,757.28 donation to the Truman Days Committee for this year's community festival (Truman Days). All yeas - carried.

A motion was made by Ebert, seconded by Nickerson to accept the deed for the Truman Chamber of Commerce Park located in the 100 block of West Ciro without stipulations. All yeas - carried.

City Clerk Monte Rohman presented the July, 2017 monthly financial reports and went over several line items.
